

PRE-AUTHORIZED TAX PAYMENT PLAN APPLICATION

The following **TERMS and CONDITIONS** apply to the Pre-authorized Tax Payment Plan.

The plan will run from January 1 to November 1 of each year. The Pre-authorized Payment Plan allows for property taxes to be paid over 11 monthly payments. Monthly Pre-authorized payments are based on the previous year's taxes, divided by 11. Payments will be recalculated as at final tax billing; at that time it is anticipated that payments will change. Written notification will be provided reflecting changes.

The Plan will not be adjusted to accommodate additional charges to the tax account – these must be paid separately. Written notification from the ratepayer and/or solicitor must be received 15 days prior to the next debit date for changes to the Plan to be implemented. (i.e. sale of property; cancellation from the Plan; changes in bank account information)

The Municipality of Callander may cancel enrolment to the Plan if any payment fails to be honoured.
