a) New Construction Multi-Residential Class

WHEREAS; The Municipality has adopted an Official Plan that contains Section 4.14.4, which encourages Council to work with developers, service delivery groups and funding agencies in an effort to create affordable housing opportunities.

AND WHEREAS; the Province as of April 20, 2017 requires all new Multi-Residential development be subject to a new tax class with a ratio range from 1.0 up to 1.1.

THEREFORE BE IT RESOLVED:

- **A.** That Council hereby resolves to set the 2018 tax ratio bylaw for new construction Multi-Residential class at 1.0.
- **B.** That Council hereby authorizes and directs the Treasurer to do all things necessary, and to execute all required documentation, in order to give effect to (A) above.

b) Waiving of Development Charges on Affordable Housing Units

WHEREAS; The Municipality has adopted an Official Plan that contains Section 4.14.4, which encourages Council to work with developers, service delivery groups and funding agencies in an effort to create affordable housing opportunities.

AND WHEREAS; The Municipality has enacted a Development Charges Bylaw that permits the entering into an agreements to waive the payment Development Charges.

THEREFORE BE IT RESOLVED:

A. That Council hereby resolves to exempt six (6) dwelling units to be located at 47 Lansdowne, from the payment of Development Charges as outlined in the Development Charges By-law 2015-1142, provided the units are affordable and receive funding from DPSSSAB.

B. That Council hereby authorizes and directs the CAO to prepare and enter into an agreement to waive Development Charges for the proposed six (6) affordable housing units located at 47 Lansdowne.

A. That Council for the Corporation of the Municipality of Callander ("Municipality") authorizes the temporary road closure of both lanes on Main St. South for the purpose of the Funfest Parade from 10:30 am to 12 Noon and from Catherine St to Park St from 10:45 a.m. to midnight in conjunction with the Callander Funfest Celebrations being held on Saturday, July 1, 2017. Local residents will be allowed access to and from any home located within temporary road closed; and

restriction on access to the parking lot on Park St, between 9 a.m. and 5 p.m. in conjunction with the Callander Funfest Celebrations being held on Saturday, July 1, 2017. Only Fun Fest vendors will be allowed to park in the parking lot during those hours. Further there will be a handicapped drop off established at the parking lot. There will also be 5 spots designated for Handicap parking along the west side of Main Street and south of Park Street. Participants in the Fun Fest Parade will be allowed to dismount their floats in the Park St. parking lot at the end of the Parade, but must subsequently remove their vehicle/float; and

- C. That Council for the Municipality of Callander authorizes the temporary restriction of access to the parking lot off the Medical Building between 8:45 a.m. and midnight in conjunction with the Callander Funfest Celebrations being held on Saturday, July 1, 2017. Only Fun Fest food vendors will be allowed to park their units in the parking lot during those hours. Furthermore, performing bands and PA system providers will be allowed to use the parking lot to unload/load their equipment before/after their performances; and
- D. That Council for the Municipality of Callander authorizes and directs the Fire Chief or designate to advise the North Bay Police Force of the temporary road closures and required police escort and other emergency services; and
- E. That Council for the Municipality of Callander authorizes and directs the Fire Chief or designate to execute all required documentation, and to do all things necessary, in order to give effect to (A), (B), (C) and (D) above.
