## EXECUTIVE SUMMARY

The Municipal Clerk/Treasurer is responsible for preparing a report that itemized remuneration and expenses paid to Council and Committees in the previous year, by no later than March 31. The total Council honoraria and expenses amount to \$116,572.15 The total Planning Committee's expenses amount to \$1,440.00.

### BACKGROUND

As per Section 284 (1) of the Municipal Act, the Treasurer shall prepare an itemized remuneration and expenses paid to Council, for the previous year by March 31<sup>st</sup> of the subsequent year and shall include the following:

- a) Each member of council in respect of his or her services as a member of the council of any other body, including a local board, to which the member has been appointed by council or on which the member holds office by virtue of being a member of Council;
- b) Each member of Council in respect of his or her services as an officer or employee of the municipality or other body described in (a); and
- c) Each person, other than a member of Council, appointed by the municipality to serve as a member of any body, including a local board, in respect of his or her services as a member of the body.

Council honoraria are calculated as per By-Law 2023-1817.

#### **INFORMATION**

As per Schedule A, the total council honoraria and expenses amount to \$116,572.15 in 2023.

As per Schedule B, the total planning committees' expenses amount to \$1,440.00 in 2023.
