Being a By-law to set User Fees and Charges for the Municipality of Callander for 2020, as amended by By-law 2022-1790 to replace Schedule A for 2023-2025, By-law 2023-1804 to add parking pass fees for Centennial Park, By-law 2023-1811 to add security deposits for facility rentals, By-law 2023-1826 to add fees under the Planning Act and By-law 2023-1835 to add rental fees for the Hec Lavigne Pavilion, By-law 2023-1849 to add Museum Administration fees and to add a Cemetery fee, By-law 2024-1905 to add various fees for 2024 such as Islander winter parking, tax fees, Pavilion Rentals, Museum Administrative Fees, Cemetery, Emergency Water Shut Off, Lifetime Animal Control Tags and to remove rink rentals at South Shore Community Centre, By-law 2014-1978 to add Open-Air Burning Permits, to add fees for the columbarium and to set the 2025 fees for the cemetery, to change the 2025 fees for Recreation and Facility Rentals, to change the 2025 rate for 91 Address signs, to add Island Property Owner parking for 2025, to add Harbour Washroom fees

WHEREAS Section 391 of the *Municipal Act*, S.O. 2001 c. 25, as amended (the Act), without limiting sections 9, 10 and 11 of the Act, specifies that those sections authorize a municipality to impose fees or charges for services or activities provided or done by or on behalf of it and for the use of its property;

AND WHEREAS on the 27th day of November 2018, the Council of the Corporation of the Municipality of Callander adopted a new User Fee Policy by Resolution 2018/11/273 to direct the frequency and methodology of updating municipal fees and charges;

AND WHEREAS the Council of the Corporation of the Municipality of Callander deems it expedient to repeal and replace By-law No. 2011-1274 and any amendments thereto and to adopt updated fees and charges in accordance with said policy;

AND WHEREAS Section 398 of the Act provides that the treasurer of a municipality may add fees and charges to the tax roll and collect them in the same manner as taxes;

NOW THEREFORE, the Council of the Municipality of Callander enacts as follows:

1. That the Council of the Corporation of the Municipality of Callander hereby adopts the Schedule of User Fees and Charges attached hereto as Schedule "A" and forming part of this By-law;
2. That the Treasurer is hereby authorized to add fees and charges for any arrears greater than six (6) months to the tax roll for the property in the municipality and collect them in the same manner as municipal taxes;
3. That By-laws 2011-1274, 2014-1396, and 2017-1533 are hereby repealed and replaced;
4. That any changes to the fees contained in By-laws 2011-1275, Taxi By-law and 2015-1469 and 2023-1833, Outdoor Vendor By-law and any other By-laws that contain fees addressed in this by-law shall be deemed to be updated by this By-law and any subsequent amendments to it;

1. That this By-law shall become effective on the 1st day of January 2020.
